

OFF-LICENCE**Sections 17 to 20 and 64, Sale and Supply of Alcohol Act 2012**

Pursuant to the Sale and Supply of Alcohol Act 2012 (the Act), Twigs at Avant Garden Limited is authorised to sell alcohol on or from the premises situated at 475C Matangi Road Matangi and known as Twigs Florist, to any person for consumption off the premises and to deliver it somewhere else.

The authority conferred by this licence must be exercised through a manager or managers appointed by the licensee in accordance with Subpart 7 of Part 2 of the Act.

Conditions

- (a) Section 49 of the Act provides that a remote sale of alcohol may be made at any time on any day.
- (b) No alcohol is to be delivered on Good Friday, Christmas Day, Easter Sunday, or before 1.00 pm on Anzac Day.
- (c) Alcohol may be delivered under the licence only on the following days and during the following hours:
Monday to Sunday 7.00am to 11.00pm
- (d) The licensee must take the following steps to ensure that the provisions of the Act relating to the sale and supply of alcohol to prohibited persons are observed:
 - (i) Display appropriate information at every point of sale detailing the statutory restrictions on the supply of alcohol to minors and the complete prohibition on sales to intoxicated persons;
 - (ii) Request age declaration from all customers before orders are placed and prior to a sale being completed in accordance with Regulation 14 of the Sale and Supply of Alcohol Regulations 2013.
- (e) The following information must be displayed on the internet site in a prominent place, in any catalogue used by the licence holder and on every receipt issued for any alcohol sold via the internet site:
 - (i) The licence holder's name, the licence number and the date on which the licence expires.
- (f) The licensee must take the following steps to ensure that the provisions of the Act relating to the management of the premises are observed:
 - (i) All staff will be trained in their responsibilities under the Act.
- (g) All floral arrangements containing wine dispatched for delivery by courier shall have affixed to the exterior of the packaging a label with the following particulars:

**COURIER WARNING
CONTAINS ALCOHOLIC PRODUCT**

- **Do not leave at destination without proof of delivery.**
 - **Do not leave with persons under the age of 18 years of age. If the receiver appears under the age of 25 years, check identification to ensure they are 18 years of age or over. (ID = Valid Passport, Valid NZ Drivers Licence, Valid HANZ 18+ Card).**
 - **DO NOT leave with intoxicated persons.**
- (h) The sale or delivery of alcohol is authorised from the premises generally. The premises situated at 475C Matangi Road Matangi are more precisely identified in a plan date stamped as received by the Waikato District Licensing Committee on 27 August 2015.

Display of Licence

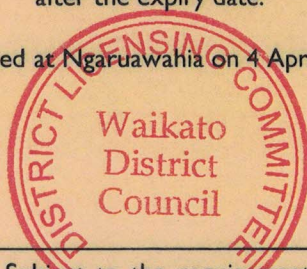
A copy of this licence must be displayed at the principal entrance to the premises. The entrance from 475C Matangi Road (475C Willowwood Lane) is designated as the principal entrance.

Duration

Subject to the requirements of the Act relating to the payment of fees, and to the provisions of the Act relating to the suspension and cancellation of licences, this licence continues in force-

- (a) until its expiry date detailed below; OR
- (b) if an application for the renewal of the licence is duly made before the licence expires, until the close of the period 3 years after the expiry date.
